Antony Howe was president of the Australasian Dr Who Fan Club from 1976-1984, president of the Sydney University Science Fiction Association from 1976-1980, president of the Sydney University Medieval and Renaissance Group from 2008-2012 and ran the Dr Who fanzine, Zerinja, from 1976-1986.

In 2003, Howe completed his PhD in English Marxist History from the University of Sydney. He has worked as an academic in this field, and most recently published a journal article in 2019.
